SEWER CAPACITY ASSIGNMENT

THIS SEWER CAPACITY ASSIGNMENT (the "Assignment") is made this _____ day of _____, _____, between _____ (the "Seller"), and _____ (the "Purchaser").

WITNESSETH:

Purchaser has, as of the date hereof, purchased from Seller, the real property (the "Property") described on Exhibit "A" attached hereto and by this reference made a part hereof. As part of that purchase, Seller has agreed to sell to Purchaser, and Purchaser has agreed to purchase from Seller, certain sanitary sewer capacity for the benefit of Purchaser's use and development of the Property.

NOW, THEREFORE, for and in consideration of Ten (\$10.00) Dollars and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Seller's Sewer Capacity. Seller represents and warrants to Purchaser that (a) Seller purchased from the City of Cumming, Georgia, _____ gallons per day of sewer capacity with respect to _____ (the "Development") and that the Property is part of the Development; (b) Seller has used or applied _____ gallons per day of sewer capacity in the Development as of the date of this Assignment; (c) Seller has _____ gallons per day of remaining sewer capacity for the Development; (d) Seller has not encumbered, pledged or assigned Seller's remaining

sewer capacity or any portion thereof; and (e) Seller has the full right, power and authority to grant and convey to Purchaser the "Assigned Capacity" defined below.

2. Assignment. Seller hereby bargains, sells, conveys, transfers and assigns to Purchaser _____ gallons per day of Seller's Sewer Capacity (the "Assigned Capacity") for the Property within the public sewer facilities of the City of Cumming, together with any and all singular rights, members and appurtenances thereof, to the same being, belonging, or in anywise appertaining to the only proper use and benefit of the Property.

3. Miscellaneous. The assignment of the Assigned Capacity is an appurtenance to, touches and concerns, and benefits the Property. This Assignment shall bind, and inure to the benefit of, Purchaser and their respective successors and assigns. The Assigned Capacity runs with the Property and cannot be sold or assigned to any other Property without the express prior written consent of the City of Cumming, Georgia. Purchaser agrees to be bound to all terms and conditions contained in the original purchase of the Assigned Capacity by the Seller or its predecessor(s) from the City of Cumming, Georgia. This Assignment will not be effective until signed by all parties, recorded on the real estate records of the Clerk of Superior Court of Forsyth County and after recording filed with the Department of Utilities of the City of Cumming, 100 Main Street, Cumming, Georgia 30040.
